# MINUTES OF BOARD OF DIRECTORS SPECIAL BOARD MEETING AUGUST 31ST, 2021 6:00 P.M.

Meeting to Order - Director Fields called the Quarterly Board meeting to order at 6:00 p.m.

Approval of July 27th, 2021 Quarterly Board Minutes – Minutes were approved as presented.

**New Business** 

Proposed Water Rates Increase – Mr. Eckard presented the proposed rate increase to the Board. Jerry Kopke who performed the rate study recommended a 2.5% annual increase. Mr. Eckard stated last year the district didn't raise the minimum bill by 2.5% only the rate per thousand gallons over the minimum bill. Mr. Eckard stated with the price increases on materials he felt a 2.5% increase was necessary even on minimum bills. The Board reviewed the proposed rate increases. Discussion followed. Director Daley made a motion to approve the proposed 2.5% water rate increase as presented; seconded by Director Ragsdale. Motion approved.

Proposed 2021 – 2022 Budget – Mr. Eckard presented the 2021 – 2022 budget to the Board. Discussion followed. Director Harper made a motion to approve the 2021 – 2022 budget as presented; seconded by Director Vaughn. Motion approved

Mr. Eckard reported Director Pratt sent an email to the Board and staff stating he has moved out of the district and is resigning from the Board of Directors effective immediately. Discussion followed. The Board agreed to advertise for the open position.

Director Fields adjourned the meeting at 6:30 p.m.
